Coronavirus (COVID-19) Updates

As a growing international pandemic, COVID-19 has become an increasing problem in the United States and across the world. As a result, the 2020 ACHE Congress on Healthcare Leadership conference in Chicago, IL has been cancelled. It is important that we all follow the CDC guidelines on social distancing and personal hygiene measures to prevent further spread. Additionally, ACHE has compiled a list of articles and resources you may find helpful during this time. Both the CDC and ACHE links are listed at the bottom of the page. We are all in this together! Please see below for the aforementioned updates:

Convocation

Any new Fellow that had planned to walk in the 2020 Convocation Ceremony, they will be invited to participate in 2021. Cap and gown fees for 2020 will be refunded by April 20, in a separate transaction from their Congress registration.

Recertification

·For those in the 2019 recertification class that received an extension to complete the requirements by March 31, this extension has been continued for the class to complete all requirements and submit recertification application and fee by Dec. 31, 2020.

·For those who are due to complete their recertification requirements in 2020, ACHE has extended the deadline to complete requirements, submit recertification application and pay recertification fee until March 31, 2021.

Board of Governors Exam

If a member had planned to take the Board of Governors Exam at Congress 2020, you should have received an email from Julianna Kazragys, FACHE, CAE, credentialing manager, with information on how to schedule your test near you at a future time.

Fellow Feature: Carl Kennedy

This quarter SC ACHE interviewed Carl Kennedy, Director at Digital & Integrated Solutions Delivery, Life Care Solutions at GE Healthcare. We conducted a brief Q & A with him to get his thoughts on the impact and overall benefits being a Fellow has had on his career.

Q: Why did you join ACHE?

A: I became interested in ACHE after being promoted into a leadership position. I was looking for industry guidance on how I approached my first "leader" role and came across ACHE. The tools, discussions and resources proved extremely useful as well as insightful then and now.

Q: Why did you pursue your FACHE?

A: Very soon after joining ACHE, I became interested in attaining my Fellow. The journey interested me as did the opportunity to give back as a colleague and mentor.

Q: What were some of the challenges you faced?

A: The journey took more than 10 years for me to actually submit my packet and sit for the exam. During this time, I found myself in the cycle of face to face hours routinely expiring. Family, work and life in general kept getting in the way. We all have things come up from time to time. It took focus to concentrate on finishing the packet and holding myself accountable for actually sitting for the exam. I had a Fellow colleague that acted as a mentor and "buddy" to help me stay accountable. I would recommend such an approach as it is a comprehensive process.

Q: What has been the biggest impact on being a Fellow had on your career?

A: I've had 2 CEO's literally tell me that I didn't need to "introduce" myself as holding my FACHE is all that they need to know. They wanted to just jump into the conversation. We immediately entered a different level of conversation with a shared respect and baseline understanding of our professional experiences.

Q: What advice would you give to those beginning the journey?

A: Achieving your Fellow is not and should not be the end point or only goal. Instead, I believe it is an important milestone on our ongoing journey to learn, mentor and evolve. Pacing and participation are extremely important for remaining engaged.

Q: What resources were helpful?

A: The materials in the toolkit were very helpful. In addition, I attended a national preparation class that was not only extremely helpful but also ensured that I had the required hours to meet the requirements for Fellow.

Case Competition Winners from Central Michigan

MUSC Hosts First Health Administration Undergraduate Case Competition

The MUSC MHA program hosted the first-ever health administration undergraduate case competition!

On October 17 and 18, the Master of Health Administration (MHA) program at MUSC College of Health Professions welcomed undergraduate students and faculty coaches from 15 colleges and universities. These health administration students competed for their chance to win up to \$1,000, funded in part by the CAHME-Aramark Innovation Grant awarded to MUSC's MHA program this year.

Of the 15 teams that presented, four were selected to move on to the final round. The finalists, from Auburn University, Central Michigan University, Loyola University of Chicago, and University of Scranton, presented their case solutions to a new panel of judges, including Patrick J. Cawley, M.D., MBA, CEO of MUSC Health and vice president for health affairs at MUSC, and Shawn Valenta, MHA, administrator of telehealth at MUSC.

After presenting for the final time, the first and second place winners were announced and presented with their checks for \$1,000 and \$500, respectively. Students from Loyola University Chicago took home the second-place prize. The first-place team made up of Olivia Arends, Kyle Chamberlain, Kayla Pung, and Catherine Young, from Central Michigan University, were the event's big winners.

The MHA program was extremely honored to host this event. It is the first time a case competition has ever been available to undergraduate health administration students, and it was a great experience for all in attendance. The Master of Health Administration Division hopes to continue the event on an annual basis.
